An Analysis of Grammatical Errors in Students' Conversation

ABSTRACT

Compose a sentence requires grammatical aspects to make good sentences. Understanding grammar is important to make sentences correctly. This study uses a qualitative descriptive method which aims to find out the types of grammatical errors produced by UPB students when conducting interviews with other students. used to collect qualitative data is the observation method. To analyze the data used descriptive method Students are given the task of interviewing other students about the lecture period which is conducted online. Then each answer produced by the student is analyzed to find out grammatical errors that have been made. found there are 15 data in 3 types of grammatical errors, among others; there are 5 pronunciation errors, 5 tenses errors, and 5 prepotition errors. It is concluded that students still cannot make good grammatical pronunciations.

analyzing the grammatical errors made by the students. in terms of pronunciation, style, and way of writing itself. Not everyone can compose sentences well because of that, grammar is also used to analyze potential errors in sentences. That way we can correct the grammatical errors of the language that we have made and turn them into correct sentences(Eunson, 2020).

In this study, the researcher used Eunson's theory to find grammatical errors. The results of the analysis found that there were three grammatical errors, including pronoun, sentence, and preposition errors. Based on Eunson's (2020) theory apart from analyzing, there is also knowledge in compiling grammar, among others; using grammatical structures accurately, spelling correctly, and placing prepositions in sentences.

This study aims to analyze grammatical errors in student conversations. This can increase students' knowledge about how to compose the correct language by using the grammar itself in conducting conversations or writing. Simbolon (2015) goal in this study was to make students better at writing using grammar structures both orally and in writing. The second is Qamariah (2020) which examines the study of grammatical errors about how students write using English. The purpose of this research is to improve and provide understanding to students so that they can make good sentence structures. And the third research is Hendriwanto (2013) who examines grammatical errors in students' narrative writing. This study aims to provide an understanding of the correct sentence structure including tenses, adverbs, verbs, pronouns, prepositions, and spelling. Researchers take and collect data about students who use English orally and in writing using a grammar structure including pronunciation, prepositions and tenses. This study aims to be an important resource in learning English by understanding its word structure.

Language

According to Martinez del Castillo (2015) to interact socially we need language in communication. Language itself is a form of tradition that has existed for a long time. Language is not only transmitted through oral but can also be transmitted through gestures or writing. Formula : Subject + had + Verb 3

• In contrast to the simple present tense, there is the simple past tense. In this instance, the simple past tense is employed to describe an action, custom, reality, or circumstance that occurred in the past. The second or past tense of the verb is used in this tense. Yesterday, two days ago, and many other adverbs of time are frequently employed in this tense.
